PARADE ENTRY AGREEMENT AND WAIVER:

In consideration of acceptance of my entry into the Marina del Rey Holiday Boat Parade, I acknowledge and agree as follows:

1. The Entrant/Boatowner/Undersigned warrants and represents that they are empowered to enter a boat, whether owned or chartered, in the Marina del Rey Holiday Boat Parade.
2. The Entrant/Boatowner/Undersigned agrees to comply with all rules and regulations governing the Marina del Rey Holiday Boat Parade, as well as comply with the safety requirements, instructions and regulations of the United States Guard (Auxiliary), Marina del Rey Sheriff's Department Harbor Patrol and Parade Committee safety vessels.
3. The Undersigned authorizes the parade organizers to utilize entrant name and parade photographs for publicity and waives and release any and all claims or causes of action arising from or related to publicity and media coverage. No commercial advertising is allowed without prior written approval of the Marina del Rey Holiday Boat Parade executive committee.
4. The Undersigned is solely responsible for all costs and expenses and will maintain sufficient insurance to protect from all risks arising from the Agreement.
5. ASSUMPTION OF RISK. The entrant/boatowner/undersigned freely assumes all risks, including personal injury or death to myself and/or my crew, loss or damage to the yacht and its equipment as well as unforeseen risks.
6. **WAIVER, RELEASE AND INDEMNIFICATION: TO THE FULLEST EXTENT PERMITTED BY LAW, THE ENTRANT/BOATOWNER/UNDERSIGNED WAIVES ALL CLAIMS, FOREVER RELEASE AND AGREE TO INDEMNIFY AND HOLD HARMLESS THE MARINA DEL REY HOLIDAY BOAT PARADE, ITS ASSOCIATES, OFFICERS, AGENTS SPONSORS, EMPLOYEES, COMMITTEE PERSONS AND BOAT OFFICIALS ACTING IN THEIR OFFICIAL CAPACITIES, FROM ANY DAMAGE, LIABILITY, LOSS, COST OR EXPENSE, INCLUDING ATTORNEY FEES ARISING FROM MY AND MY CREW'S PARTICIPATION IN THE MARINA DEL REY HOLIDAY BOAT PARADE, INCLUDING THE MARINA DEL REY HOLIDAY BOAT PARADE'S ACTIVE OR PASSIVE REGULAR NEGLIGENCE, BUT NOT THE MARINA DEL REY HOLIDAY BOAT PARADE'S WILLFUL MISCONDUCT OR GROSS NEGLIGENCE.**
7. The Entrant/Boatowner/Undersigned expressly acknowledges the accuracy and correctness of the information submitted and has carefully read, understand and agree to the above.
